#### SCHOOLS CORNER by Julie Merberg

If you have driven on Old Georgetown Road recently, you are likely well aware of the progress being made on the construction of the new Woodward High School. The project is currently on track to open to students in August 2024. Unfortunately, the construction timeline of Northwood High School has been extended, which will in turn

delay by one year the re-opening of Woodward High School to provide much needed capacity for Montgomery County Public Schools (MCPS) and to alleviate overcrowding at Walter Johnson High School.

Previously, MCPS planned to relocate students assigned to Northwood High School to the newly constructed high school on Old Georgetown Road for two years while Northwood was being rebuilt. After serving as holding school, Woodward would open to local students in August 2026. However, the construction timeline for Northwood has been extended, and now Woodward will be used as a holding school for three years delaying the re-opening of the school until August 2027.

This one year delay will have a direct impact on current and future Walter Johnson High School students as WJ continues to operate at 130% of its capacity. The school has added 15 relocatable classrooms, but students are finding that hallways and classrooms are crowded as the school struggles to accommodate over 3,000 students in a space built for 2,300.

In other Walter Johnson High School news, the school's long-serving principal Jennifer Baker retired in December. WJ vice principal Nicole Morgan is serving as acting principal, and Ms. Baker's permanent replacement will be announced in the near future. In the wake of the departure of Superintendent Monifa McKnight, who resigned following controversy over the handling of sexual harassment allegations against a former principal, the principal appointment process may be slowed.

#### COMPOST CREW UPDATE by Jerry Mindes

When left in the trash, food waste goes to the county incinerator, using fossil fuels and generating pollution. Composted food waste supports organic agriculture. Compost Crew is a private composting company that offers a weekly pick-up service of food waste. The GFCA negotiated a reduced rate, based on the number of subscribed households. Currently, 28 homes receive weekly pickups from Compost Crew, at \$28 per month. (The starting price was \$34 a month). If six more households join, the monthly price will be reduced to \$25 for all participating households.

To help reach our target goal of 34 households, Casey Henderson will be reaching out to families on his block of Rolling House Road to encourage then to sign up. If you a current Compost Crew subscriber, please consider doing the same on your block. If you are interesting in signing up, please contact Casey, ch2001@aol.com, and Jerry Mindes, jerrymindes@gmail.com, to let us know. When we get to six new interested households, we will contact Compost Crew as a group and secure the lower rate of \$25/mo for all 34 households.

# FIGHT JUST THE MOSQUITOS by Marjorie Raley

Commercial mosquito sprays and commercial mosquito spraying companies harm beneficial insects and their predators, such as birds.

**THE BUCKET OF DOOM** is an inexpensive, effective trap you can make yourself. Here's how to set it up: Get a bucket, preferably a 5 gallon one, and put 3 or 4 handfuls of straw, hay, or leaves inside. Fill the bucket about halfway. Let this sit in a sunny or partly-sunny location for about 3 days until it is fermenting. Add a Mosquito Dunks pellet, which will float on top and slowly dissolve over 3 to 4 weeks. If you have critters which will disturb the bucket, cover with chicken wire.

Here's how it works: The fermented brew in your bucket is an irresistible location for female mosquitos to lay their eggs, because it multiplies what mosquito larvae eat. Those larvae are doomed, by the bacteria released by the Mosquito Dunks pellet. The bacteria is toxic to the larvae and fungus gnats, but harmless to other insects, wildlife, birds, pets, and humans. A 6-pellet pack of Summit's Mosquito Dunks sells on amazon.com for about \$10, and is more than enough to get you through the summer. Put 1/4 of a pellet directly in your birdbath to keep it free of mosquito larvae, too.

# I-270/BELTWAY TOLL LANES AND LANE WIDENING by Ed Rich

In January, the federal government rejected the State's grant application for the proposed toll lane and lane widening projects on the Beltway and I-270 and the Governor's proposed \$3 billion budget reduction in transportation funding due to slowing state revenue. On February 8, I, along with fellow members of the MD Advocates for Sustainable Transportation (MAST) Coalition, spent the day at the MD Senate and House offices requesting that the funding be reallocated to projects that would actually provide equitable and efficient transportation, alleviating traffic congestion. We advocated that the limited funding for transportation provide the greatest benefit to everyone, such as establishing a stable source of funding for METRO; expansion of daily MARC rail service; reliable, affordable and convenient bus rapid transit, providing affordable workforce housing adjacent to transportation, and employer tax incentives for telework and staggered work hours. We continue to advocate on behalf of our neighborhood and others affected by this ill-conceived project and welcome your input.

# LEGISLATIVE NEWS FROM ANNAPOLIS-DISTRICT 16 by Ed Rich

Delegate Sarah Wolek, who came to our Community Meeting in November, is attending her first session of the Maryland General Assembly and is focused on creating policies that enhance human flourishing and well-being. She has sponsored bills to establish pilot financial literacy programs for college students at UMD College Park and Morgan State Univ., to establish a pilot program within the Dept. of Aging, to create a consortium of senior villages (such as our North Bethesda Senior Village) with common administrative staff so that individual senior villages can provide direct services to seniors, and to create more Green Schools, supporting students as they connect with nature and become environmental stewards.

Delegate Marc Korman, who chairs the House Transportation and Environment Committee, sponsored a bill that has passed the MD House that removes restrictions on Metro funding. He also sponsored a bill to address the increasing incidents of cultural and religious bias on a statewide level. The legislation would require each county school board, colleges, and universities to train employees on antisemitism and islamophobia and require the State Dept. of Education to conduct an independent assessment of Holocaust education in state middle and high schools.
