## Letter from the President

Greetings from the Greater Farmland Civic Association. A warm welcome to those of you who have recently moved into our community.

The GFCA has had a busy year sponsoring community events. The 3rd annual community yard sale had record participation of 64 households. Participants sold many items and made some money in the process. Thanks to Karen Lipsy for her hard work.

Despite the rain, we had a wonderful July 4<sup>th</sup> Parade and celebration at the Old Farm Pool, complete with street flags, fire trucks, police cars, and our own patriotic band. Many thanks to all of you who volunteered your time and talents in order to make this event memorable.

We have had a busy year representing you on issues of neighborhood concern. Your Association worked hard to make sure that our voices are heard by the Board of Education and the County Council regarding the proposed relocation of the Tilden Middle School to its original location on Tilden Lane. We will continue to remain active this fall as the Board of Education carries out its feasibility study to ensure that the new school meets our kids' needs, addresses potential traffic concerns, and ensures the safety of walkers and bikers.

We provided testimony to the Maryland Public Service Commission, opposing the proposed merger of Pepco with Exelon, arguing that it offered limited benefits and was inconsistent with the goal of moving away from traditional power generation and toward renewable energy.

GFCA is working with other organizations, such as the Friends of White Flint, the Coalition for Smarter Growth, the Park Potomac Homeowners Association, and the Montgomery Square Citizens Association to prevent the elimination of the Ride-On Route 42, which currently serves our community on Montrose Road. We are confident that our efforts will lead to a reversal of the discontinuation decision by the County Council.

We are monitoring local redevelopment to ensure that projects are consistent with the vision of an urban town center that is walker and biker friendly and will be a lively and active destination for us. As members of the White Flint Implementation Committee and the Friends of White Flint, GFCA advocates for the creation of a Regional Community/Senior Center at Wall Park and the Shriver Aquatic Center, the creation of more green space, and measures to ensure that new development has limited impact on our neighborhood streets.

News

A diverse group of speakers made presentations to our community this past year at our general meetings at Farmland ES. Our Second District Community Relations Officer advised us on home, neighborhood and traffic safety, a home inspector told us how to address issues within our homes, representatives from the Washington Suburban Sanitary Commission talked about brown water and the state of our water and sewer pipes, and representatives from the Montgomery County Parks Department discussed plans for upgrading the Tilden Recreation Center. This project was initiated by the GFCA, and we provided input as to what we would like to see in a renovated recreation center.

Many thanks to our dedicated Board members for their yeoman's work on behalf of the Association and the community. (*continued on next page*)

#### **Energy and Government Affairs Committee**

The committee now has a charter to define the scope of its work. It will advise and assist the Board on issues largely related to our county government and utility services. It will also provide Paul Arveson, Chair news and tips on energy efficiency, smart home ideas, pollution, noise etc.

TIPS from Committee Chair Paul Arveson:

- County governments handle a vast number of services for residents. Montgomery County has made it easy to obtain information simply by dialing 311 for non-emergency government services or use this web link: mc311.com
- Montgomery County has set a goal of 70% recycling of trash by 2020. Note that housekeeping services may not follow recycling rules. If you use a service, please pre-sort your trash into the recycling bins before your housekeeper comes. This will help our county achieve its goal.
- We are entering the "noisy" season -- the season of leaf blowers. Our county has a noise ordinance restricting noise levels in residential areas. The limit is lower from 9pm - 7am. Some landscaping employees do not have hearing protection, although this is an OSHA requirement. We can provide you with quality earplugs to give to employees; contact me if you want some. We include a safety message in English and Spanish. As we interact with utilities and local government agencies, we will pass along news and tips to the

community via this newsletter, the email list, and in community meetings. Feel free to contact me if you have some tips to share regarding county services. PaulArveson@gmail.com 301 523-4540

### **Neighborly Reminders**

- If you are posting private or commercial signs (estate sale, rental, lost pet, services advertised, etc.), please remove them in a timely manner. The county has regulations that prohibit most signage not on private property. Civic Association signs will be posted and removed accordingly, as the county approves.
- For homes with sidewalks, please trim encroaching shrubs and overhanging trees
- Call the county at 311 to report potholes
- It is illegal to leave yard trimmings in the street or to put them in the storm drains. Please ask your landscaping company to comply with county law.

#### **Transportation Committee**

The Transportation Committee has been moving! We ...

- filed a letter to the Montgomery County Dept. of Transportation imploring it to keep Ride On Route 42 on Montrose Road and to look at other ways to cut costs that don't involve eliminating the bus many of our neighbors depend on.
- sent a letter to Farmland Elementary parents reminding them to **drive safely** on our neighborhood streets.
- made connections with the Luxmanor and North Farm citizens groups so we can work together on common interests. We
- talked with the county about the traffic counters on some of our neighborhood streets and found out that they are part of the White Flint traffic study, a report on which is coming out soon.
- We will be pursuing traffic law enforcement on our streets with an increased police presence, as well as trying to get all-way **stop signs** at some key intersections.

Keep Our Streets Safe - Follow all the traffic laws when driving in our community and remind your teen drivers and others to do the same. Particularly as it starts to get dark earlier and the sun comes up later in the morning, be aware of kids traveling to and from bus stops in the dark. Please help make our community a safe place to move around and follow the rules of the road (and sidewalk) when you are a driver, cyclist, and pedestrian. Thank you!
