Schools

MCPS Superintendent Jack Smith has released a report on overcrowding in our schools and has made recommendations to the Board of Education. The full report can be found at montgomeryschoolsmd.og/departments/planning/cipmaster.aspx.

Here is a summary of the actions taken by the Board of Ed early in November. Administrators, staff, PTAs, and GFCA community members have worked tirelessly for the current set of solutions. We thank all of those active in this process.

For our community, three key points emerge:

- 1. The Tilden renovation is now a full go at the Tilden Lane/Marcliff Road intersection, with the middle school population to be relocated to the new facility.
- 2. The BOE will re-open Woodward as a high school once Tilden Middle School has moved out. The purpose will be to reduce overcrowding at Walter Johnson High School and to keep the cluster intact.
- 3. Farmland Elementary School will be monitored for enrollment numbers with some re-assignment possible after Luxmanor Elementary has been renovated in 2020.

GFCA Beautification Projects in the Works

The Beautification committee is obtaining estimates to replace missing lettering on Tilden Woods and Old Farm (brick) community entrance walls. Locations: Montrose Road/Tildenwood Lane (east & west walls), near the corners of Old Stage Road/Tildenwood Drive, and Tilden Lane/ Stonewood Lane

We are also seeking bids to rebuild the failing brick entrance wall by Tilden Lane/Stonewood Lane (near 6901).

The Dept. of Transportation has our request to remove ten dead trees bordering streets/sidewalks within the GFCA community.


Consultations are underway with a potential new contractor to provide scheduled annual

maintenance for approximately 17, currently landscaped, common areas (circles, medians, entrances). More to follow, after January.

In the future, we hope to establish a Garden Club.

Highlights of October GFCA Community Meeting

The GFCA held an informative community meeting on October 18th. The 80 folks who attended received timely information and advice from Officer Oliver Janey, Montgomery County Police, District 2 Community Relations, WSSC Old Farm Creek Stormwater Restoration Project Team representatives, and Tim LaCoste of State Farm Insurance.

Officer Janey addressed community members on the topics of community awareness and traffic safety. If you see something in progress, you should only call 911 to report a true emergency. Other concerns should be reported via the Police Non-Emergency number (301) 279-8000. Officer Janey said that neighbors who see a crime or suspicious activity should request an officer visit them and take a report, not simply phone it in. Residents should not attempt to stop the actions underway without police assistance. On traffic issues, Officer Janey told the community that when they witness traffic violations, such as speeding and failure of drivers to come to a complete stop at stop signs, cell phone videos and/or a description of the car, including make, model and tag number are very helpful to police in following up on such concerns. He encouraged community members to call the Non-Emergency number to report all concerns and to follow the rule, "If you see something, say something."

The WSSC Old Farm Creek Stormwater Restoration Project Team reported on the Storm Restoration Project for Old Farm Creek from the end of Old Club Road northward along the creek toward Tilden Woods Park. The purpose of the project to is restore and stabilize Old Farm Creek, reducing erosion of the creek beds, removal of debris from the creek, protection of mature trees in the area, stabilization of the outflow tributaries from the creek and protection of existing infrastructure. The project will take place over a 10 week period from December 2016 through March 2017. Work on the project will take place Monday through Friday from 7 AM to 7 PM. Access to the staging site will be at the end of Old Club Road. Truck traffic through the neighborhood should be expected during the project during such times that it does not conflict with local school traffic. Roads in the community will be evaluated pre and post project and any necessary repairs to roads which might be damaged during the project will be made by WSSC.

Tim LaCoste, with the State Farm Insurance Company, addressed the community on matters related to homeowners insurance and roof replacement claims in light of the hail storm in May. Mr. LaCoste advised community members who had questions about whether specific situations were suitable as homeowner's insurance claims to consult with their insurance agent. Mr. LaCoste indicated that homeowners make sure that their policies include a special endorsement to cover situations such as water intrusion from backed-up sewers and drains. He explained that damage from falling water is covered but damage from rising water is not without a separate flood insurance policy. As for insurance costs, because the hail storm was considered a catastrophic event, a claim for roof damage would most likely not be considered a claim against an individual's policy but may affect everyone's rates down the road.

Free or Subsidized Transportation Services

Did you know that many of us can use the Ride-On buses for free? **Riders who are 65 and older and persons with disabilities** with ID's can ride free between 9:30 AM and 3:00 PM Monday through Saturday. **Students in grades K-12** can ride free from 2:00 – 8:00 PM weekdays with a Youth Cruiser SmarTrip card or a valid school ID. We have two routes that run along Montrose Road: Route 81, which runs during AM and PM rush hours Monday-Friday, and Route 42, which runs all day Monday-Saturday. The County has also a Call-n-Ride Program that provides subsidized taxi trips for **seniors and low-income persons with disabilities**. To be eligible for the Call-n-Ride Program, you must either be low income and at least 65 years of age or low income, or 18 years of age or over with a disability. Metro Service Under Attack

Many of us depend on Metro to get to and from work or for other trips around our region. As part of the proposed Metro budget, service cuts have been proposed for the White Flint Station and others north of White Flint. During peak hours, trains would serve the station every 8 minutes, rather than the current 6 minutes. During non-peak hours, trains would come every 15 minutes, rather than the current 6-10 minutes. Your association is working with Friends of White Flint to ensure that service gets better, not worse. Here is an excerpt from a letter we sent to Metro:

"As residents, property owners, government employees, and businesses, we are strong supporters of Metro. We use Metro to get to jobs, homes, and entertainment, and we believe Metro is an indispensable part of our community. It is because we believe in Metro that we are convinced that service cutbacks as described in WMATA's proposed budget would be extraordinarily damaging to not just the White Flint/Pike District area but also the entire metropolitan area. Quite simply, headways at the WMATA White Flint Station must remain every six minutes during peak times, and headways must be far more frequent than the proposed fifteen minutes during non-peak hours. Diminished service during both peak and non-peak times would decimate the White Flint/Pike District area."

Safety Tips from the Transportation Committee

Here are a few reminders related to road safety on our neighborhood (and other) streets, for drivers, bicyclists, and pedestrians alike.

We have gotten requests in the past for info about school bus stop times. Middle and high school students are waiting at bus stops all over the neighborhood between about 7:00 and 8:00 in the morning and walking home from bus stops between about 2:30 and 3:30. Additionally, many students and families are traveling on foot, bicycle, or scooter to and from elementary schools -- and safety patrols and crossing guards are stepping into some intersections -- between about 8:30 and 9:45 am and about 3:00 and 4:15 pm. Please be mindful of kids walking to/from bus stops and school and waiting for the bus, particularly as winter approaches, it's dark earlier, and some bus routes do not have sidewalks.

Montgomery County is ramping up enforcement of the law that school buses with red lights flashing cannot be passed. See a video from MCPS at montgomeryschools.md.org/mainstory/story.aspx? id=498923.

Fall Leaf Collection

Fall is upon us, which means that our neighborhood of tall, mature trees has lots of leaves to deal with. Some of you have county collection, while others do not. For those of you who do, leaf collection is underway, and you are billed approx. \$160 on your annual property tax bill for leaf collection and weekly trash collection. For those who don't, or who didn't get their leaves raked in time, the County collects bagged leaves and yard waste weekly on recycling day. An easy way to deal with leaves is to have a mulching lawn mower cut up the leaves where they fall so that they provide nutrition for the grass and soil during the fall and winter months, which lessens the need for chemicals and other fertilizers.

What's Happening Around Pike and Rose?


As many of you know, the areas surrounding Rockville Pike from Montrose Road south to Edson Lane are in the process of being redeveloped from strip shopping centers with acres of parking into a more urban district with shops, restaurants, apartment-type housing and office space. Over time, the area will become more pedestrian and bicycle friendly, with wide sidewalks, shorter blocks, on-street retail and bike-jog lanes.

Pike and Rose, at the intersection of Rockville Pike and Old Georgetown Road, has finished its Phase I development and is now working on Phase II, which will, when it opens at the end of next year, include more retail (REI, Pinstripes, H&M, Sur la Table, Taylor Gourmet, Red Door Salon), a new Canopy by Hilton Hotel, apartments/condominiums, a public library, and gathering spaces.

2017 will also herald the construction of a new high-rise apartment building where McDonalds now sits, which will mean the demolition of half of the adjacent shopping center. There will be restaurants/retail on the ground floor and a newly created gathering space in front of the new apartment building.

The reconfiguration of Old Georgetown Road and Executive Boulevard is underway. Named the "Western Workaround," it will realign Executive Boulevard where it meets Old Georgetown Road, and creates a new street, Market Street, behind the Marriott Hotel and Conference Center. The realignment creates a rectangular parcel that will become an apartment community call The Gables, located behind the Shriver Aquatic Center. The road behind Pike and Rose will open to Old Georgetown Road at a newly-configured intersection. More information is available at pikedistrict.org/future.

What are the Next Plans? White Flint Phase 2

The Montgomery County Planning Board has released a draft plan for the second phase of revisions to the current plans for the White Flint area. This one involves the areas surrounding the existing White Flint sector and includes the Executive Boulevard office buildings, the areas on Rockville Pike north of Montrose Road between Executive Boulevard and Nebel Street (including the shopping center where the Giant is) and areas east of Nebel Street south of Randolph Road. The Plan envisions the future of the area between the White Flint Sector Plan area and the City of Rockville by recommending opportunities for infill and transitional development at key locations. Commercial properties, especially shopping centers along Rockville Pike, are likely to change into mixed-use urban places. GFCA is a member of the White Flint Implementation Committee and is actively monitoring the plan.
