PLEASE REMIND YOUR YOUNGSTERS-STREETS ARE FOR CARS

Skateboarding, riding scooters, pushing strollers, and walking down the middle of our streets is a tragedy waiting to happen. Old Stage Road, Tildenwood Drive, Farmland Drive, and Tilden Lane are designated residential access roads, with endemic speeding. Other streets, without sidewalks and with parking on both sides have limited lines-of-sight. We have had reports of children, with and without adults, in dangerous situations.

COUNTY PROPOSES CHANGES TO SHORT-TERM RESIDENTIAL RENTAL RULES

Montgomery County officials are considering a proposed Zoning Text Amendment (ZTA) 17-03 and a companion Bill 2-16, which would authorize all County home owners to offer unsupervised (meaning no owner presence required) rentals for up to 90 days per year, with certain limited requirements. (The maximum consecutive rental days would be 30.) This ZTA would enable homeowners to advertise availability of rooms or an entire home for rental with online services such as Airbnb, HomeAway, VBRO, and other similar online short-term rental sites.

Currently, the County's Zoning Ordinance does not allow for short-term residential rentals of less than one month, unless the home has been approved for use as a "Bed and Breakfast." Bed and Breakfasts are only allowed in detached houses and are subject to specific standards.

Since 2016, the County has been considering revising the existing Zoning Ordinance to permit short-term rentals. At the GFCA board's July 17th Board Meeting, the Board authorized directors to draft testimony for the September 12 County Council hearing. The central concern was that the current proposal fails to provide for adequate enforcement and penalties, given the risks posed by permitting up to 90 days of unsupervised rentals.

The Board's testimony recommends that the County Council revise the proposal from a ZTA to a Landlord-Tenant Regulation, with adequate civil penalties for violations of the proposed limitations as well as for other violations. This would include fines and the ability to revoke rental licenses for repeat offenders. Enforcement should not depend on neighbors reporting violations to the County.

The testimony is posted on the GFCA website, along with resource links and further information.

POLLINATOR-FRIENDLY GARDENING TIPS FOR FALL

If you garden, as I do, to attract and nurture bees and butterflies, fall is as critical a time of year as spring and summer. You may want to sow new seeds. Aim for a variety of plants that produce nectar and pollen throughout the season, such as native monarda (Wild Bergamot is a favorite), anise hyssop (a wonder plant), beardtongue, butterfly weed, and asters. Also consider how you prep your garden for spring. Many butterflies over-winter as eggs and caterpillars nestled in leaf litter, and many bees nest in the ground, pieces of wood, and

hollow plant stems. Leaving the leaf litter undisturbed under the pollinators' favorite plants and leaving a couple of feet of stem when trimming dead stalks are two ways you can encourage more pollinators in spring.

With a huge number of volunteers organizing sign-ups, street signage, advertising, and handing out maps, our yard sale in June had a record-breaking 62 participating households! GFCA TESTIFIES FOR NEW SCHOOLS IN CLUSTER

This past June, Ed Rich, GFCA President, testified before the County Council in support of the Walter Johnson Public School Cluster's opposition to the Rock Spring Master Plan unless it or one of the other Sector Plans being considered by the Council this year is amended to incorporate a sufficiently sized site for a new cluster Middle School. The currently proposed Plan allows for 4,113 new housing units. This is in addition to the White Flint Sector Plan's allowance for 9,800 additional housing units (a total of 14,341), White Flint 2's allowance for 7,842 new housing units, the proposed development of the WMAL tower site with 309 new houses and the EYA 168 townhomes Montgomery Row project, under construction. In adopting the Rock Spring and White Flint 2 plans, the Planning Board neglected to identify a site within one of the plan's boundaries that would be reserved for a new middle school. As we stated in Ed's testimony, "Instead, it takes a wait and see attitude, hoping that someday a developer will come along with an Optional Method Development proposal that will somehow miraculously include a middle school in exchange for increased density. This is pie-in-the-sky thinking." Ed also testified before the Council on the White Flint 2 Sector Master Plan on behalf of the GFCA in September.
