GFCA TRAFFIC AND PEDESTRIAN SAFETY COMMITTEE UPDATE by Jason Smith, Chair

In September 2021, the GFCA Board tasked the Traffic and Pedestrian Safety Committee to prioritize pedestrian safety along Hitching Post Lane in response to neighbor concerns about pedestrian safety on this street. Hitching Post Ln. is narrow and carries a high volume of vehicle traffic. Its proximity to Farmland Elem. School, the two MCPS bus stops on that street, and its through-access in the community means it also has a lot of pedestrian & bike traffic. Parked cars on both sides result in an extremely narrow path of travel, with line-of-sight obstructions. At least two pedestrians have been struck by vehicles.

Working with the Montg. Cty Dept. of Transportation, the Committee vetted over a dozen proposed solutions and considered numerous traffic mitigation measures (e.g., changing MCPS bus routes, shifting traffic, etc.). With most proposals deemed unworkable, the Committee identified three viable solutions, the subject of a recent community-wide online survey. Households from affected properties along Hitching Post Ln will be individually canvassed via paper survey and informational flyer.

The online survey responses show that the community overwhelmingly supports the installation of a sidewalk on one side of Hitching Post Lane on the block between Old Stage Road and Old Gate Road (more than 70% of the more than 100 households that responded chose sidewalks as the preferred solution). This is true, even when considering only respondents who reside on Hitching Post Lane; nearly 50% of the households on Hitching Post Lane favor installation of sidewalks over one-side restricted parking (25%), or taking no action (28%).

The Committee continues to analyze survey data and will evaluate data from the upcoming paper surveys. We continue to work with the community to address this and other safety issues.



UPDATE! I-270 PROJECT IS ON HOLD FOR NOW by Ed Rich

We have been opposed to Governor Hogan's plans to turn I-270 over to a private company in a 50-year contract to add four toll lanes to I-270 from the Beltway to I-370. His proposal is an environmental disaster for our neighborhood, and it would not solve traffic congestion issues. We have taken that message to the County Council, the Montg. Planning Board, the County Executive, the MD General Assembly, the Governor's office, the MD Board of

Public Works, the State Comptroller, the MD Dept. of Transportation, and the federal Dept. of Transportation. We advocate for solutions, such as expanded rail service along the 270 and 495 corridors that cross the American Legion Bridge, increasing telework and flexible work hours, improvements to rail (Metro, MARC, Monorail or rail service on the I-270 corridor), and expanded development of Smart-Growth communities around major transit hubs. We are partners with the Citizen's Against Beltway Expansion, Don't Widen 270, the Sierra Club, MD Advocates for Sustainable Transportation, the MD Climate Coalition, and the Coalition for Smart Growth. We have pushed the state and the federal government to reexamine Gov. Hogan's and MDOT's misinformation and to consider alternatives that can address transportation issues in an environmentally and economically sound way.

The MD Depart. of Transportation has delayed submission of the private company contract to the Board of Pubic Works until after Governor-elect Wes Moore is sworn in. Therefore, if it is presented at all, the board will consist of Gov. Moore, Comptroller Brooke Lierman, and Treasurer Dereck Davis. Governor-elect Moore has stated that he wants to see a "new type of proposal," emphasizing reversible lanes (a concept advocated by County Executive Elrich), increased transit and greater collaboration with local "stakeholders." Elrich said that the focus should be on the use of federal infrastructure funds to address the real bottleneck, the American Legion Bridge. Elrich stated: "We can do this right. It doesn't have to be this expensive. It doesn't have to be this destructive." We will continue to work with advocates and State and County officials to support alternatives that are economically viable and environmentally sound and welcome your continued input.

ON OCTOBER 25, THE MONTGOMERY COUNTY COUNCIL APPROVED THE 30-YEAR GENERAL MASTER PLAN, CALLED THRIVE 2050

A general plan does not furnish a legal basis for a zoning text amendment. However, Thrive 2050 includes a desire for more housing types in single family residential zones to meet the County's long term housing needs, and includes draft text that may permit duplexes and triplexes in areas presently zoned for single family homes, if the local master plan allows it. The Planning Board wanted to see if the Council approved Thrive 2050 before sending specific draft text. There is nothing I heard in the Council debate that would cause the Planning Board not to go forward with drafting text language.

The next step is for Planning Department staff to draft the text needed to accomplish the Attainable Housing Strategies. That document will run to several hundred pages, because of necessary conforming amendments. Since the County Council recently replaced the Planning Board members with temporary members, it remains to be seen if the temporary Board wants to wade into these controversial waters. If it does, there would be a formal public hearing before any text can be sent on to the Council.

I want to state again that this proposal will have little effect on our neighborhood. Planning Dept. staff has indicated that a project to convert an existing home to two or three units would only be financially feasible if the property was valued at 70% or less of market value and, once converted, could be sold for at least 130% of market value. Indeed, one of the criticisms of the proposal was that it would be ineffective in solving the housing shortage.

ATTRACTING BUTTERFLIES WITH MILKWEED AND OTHER NATIVE PLANTS

- 1. **Butterfly weed** is beautiful, deer and rabbit resistant, and fairly drought tolerant. Plant it where it gets at least 4-5 hours of sun, adding some sand to your clay soil to prevent root rot. Pile leaves over it in winter, but clear them off in Spring so the shoots can sprout. Mine come up fairly late, late May to early June.
- 2. **Common milkweed**: This plant can produce lots of caterpillars! Caveat: this species spreads very aggressively. Plant it where you don't mind it taking over, not close to a neighbor's yard, unless they want it, too.
- 3. **Swamp or Rose milkweed**: Very well-behaved. It spreads slowly by seed. It needs at least 4-5 hours of sun and soil that stays a bit moist. In dry soil, it comes and goes too quickly to provide food for the Monarchs.
- 4. **Purple milkweed**: Slow to establish and not aggressive. Mine is about 4 years old and getting to be very pretty.

As for **flowering plants that attract butterflies**, here's the usual advice:

- 1. Native plants attract bees and butterflies better than most non-natives. Some natives have been "engineered" into varieties claiming longer bloom-time, better pest resistance, etc. These varieties may have less nectar and pollen, and may have changes to bloom time-frame or flower structure that may deter butterflies & specialist bees.
- 2. Try to have plants that flower at different times so that your butterflies have a continuous source of food.
- 3. Look into going beyond just providing nectar. Add plants that butterflies lay eggs on and feed caterpillars. You might be surprised to see that you already have some of these plants. Leave them untrimmed through winter.
- 4. Don't spray pesticides on plants you want the butterflies to visit!

JULIE MERBERG'S SCHOOLS CORNER

By the Numbers

Current enrollment at Farmland Elementary is 801 students. With a capacity of 737 students, this puts the school 64 students over capacity, requiring the use of portable classroom buildings.

The newly constructed Tilden Middle School has a capacity 1,244 and an enrollment of around 1,100 students.

Walter Johnson High School has slightly under 3,000 students, with 834 students in the current freshman class. Despite 2009's renovations, the school is now 650 students over capacity, with 15 portable classrooms.

Woodward High School will serve as a holding school for two years, then will open to our neighborhood students for the 2026-2027 academic year, with a projected capacity of 2,159 students. 2026 represents a one year delay from the original planned opening. The contractor posts updates at hessconstructionwoodwardhs.com/.

With two of the three schools over capacity and plans for several new apartment complexes, school construction will continue to be a top issue for the Farmland community.

Tilden Lane Traffic

With the opening of Tilden Middle School and Rock Terrace School, there are now five schools - with over 2,500 students plus staff - which rely on Tilden Lane to get students safely to school. School traffic is compounded by neighborhood commuters and cut-through traffic.

The Farmland and Tilden community is working with MCPS to restore bus service to our middle school students who became ineligible for bus transport when the school moved from Old Georgetown Road. This may alleviate some traffic on Tilden Lane during school hours, but please watch out for the walkers, joggers, and bike riders.
