GFCA IS ACTIVELY RESPONDING TO HOGAN'S I-270 PROPOSAL by Ed Rich, president

We are members of three organizations opposing the expansion project, <u>Don't Widen 270</u>, <u>Citizens Against Beltway</u> <u>Expansion</u>, and <u>Maryland Advocates for Sustainable Transportation</u>. Several bills were submitted to the General Assembly this spring regarding issues with Hogan's proposal, and the GFCA submitted testimony and co-signed letters, along with such groups as the <u>Sierra Club</u>, the <u>National Parks Conservation Association</u>, the <u>Coalition for Smart Growth</u>, the <u>Chesapeake Bay Foundation</u>, and the <u>Washington Area Bicyclists Association</u>. Delegate Marc Korman introduced The Promises Act and another bill that would create a legislative oversight panel for public-private partnership projects, require a full environmental impact statement be completed prior to any pre-solicitation documents being issued, and prevent a selected contractor from blocking locally supported transportation projects. These bills will have to be pursued in the 2022 MD Assembly and promoted by us, since they failed to complete passage this year.

Interested in joining the I-270 committee? We will be monitoring hearings, formulating position papers, coordinating with our partner organizations, and communicating with the community. We will work with Congressmen Raskin & Brown to ask the Secretary of Transportation, Pete Buttigieg, to reevaluate this highway project and remove federal funding if it doesn't comport with President Biden's goals for federal infrastructure.

GFCA is joining with other groups to urge the MD Board of Public Works not to select a contractor for the project until the completion of the <u>Environmental Impact Statement</u>. COMMUNITY MEMBERS JOIN IN "CONVERSATIONS WITH YOUR NEIGHBORS" P. 2 AND "CONVERSATIONS WITH EXPERTS" ZOOM SERIES by Emily Mintz

I hardly know where to begin to tell you how deeply these conversations have touched me. These series have enriched my life and expanded my understanding. I have met new friends whom I hope to get to know better.

The **Conversations with your Neighbors** group has met six times to discuss podcasts in the series "Seeing White" from Scene on Radio. We have examined American history, society, and interracial relations from diverse points of view and experiences. If you haven't been following along, I sincerely encourage you to go to **sceneonradio.org/seeing-white**. Each episode is available for free download, and a transcript is provided. The intention of the Workgroup that organized this Zoom series has been to foster discussion, educate, and create understanding among us. I, for one, am the wiser for it. Thank you to the "Conversations with Your Neighbors" leadership. Please check out the podcast series; it will alter your universe.

There has been one **Conversations with Experts** Zoom meeting since the last newsletter. We met with Councilmember Will Jawando, who is spearheading police and justice reform measures in Montgomery County. He outlined the history of policing and defined some future issues, such as vetting who is hired as a police officer, motivations for police officers, standards of when deadly force is permitted, and force accountability and transparency. Bills that have passed include a statistics and tracking data bill and the Law Enforcement Trust and Transparency Act, which requires an independent investigation whenever a citizen is killed, with the report to be made public. He is hoping to get the state to set up a separate body for independent investigations. The reimagined police force could be used for serious crime, not for ancillary lesser infractions. For schools, he proposes that the school resource officer (SRO) budget of \$3M be reallocated to school counselor and social work services. Current mental health management training for police is too basic. Montgomery County is talking with the CAHOOTS program, which has 911 triage capability to send the right people to each situation, be it homelessness, drug abuse, or mental health crises. Funds may be allocated to create six crisis intervention teams over the next few years. Traffic enforcement may be given to DOT, with a higher reliance on increased automation (speed and traffic light cameras). The county has asked for ideas and models. Councilmember Jawando also is making proposals to increase affordable housing and reevaluate housing type zoning near transit, an anti-rent-gouging bill for transit-accessible areas, increasing the affordable housing fund, and increasing funding for social services.

Conversations in the Future. The Conversations Workgroup will merge the two series to work in tandem with each other. Periodically, we will invite the GFCA community to a Zoom "Conversation with an Expert(s)" presentation, and then hold a later Zoom "Conversation" to discuss the speaker(s) and topic of that meeting. *Watch the listserv & GreaterFarmland.org for topics and scheduling*.



Two Greater Farmland General Meetings Featured Additional Prominent Legislators and Policy Makers

On March 11 and 24, many neighbors joined Zoom meetings to discuss policy and progress with County Executive Marc Elrich, State Delegate Arianna Kelly, and our District 1 Councilmember Andrew Friedson.

County Executive Marc Elrich shared latest proposals for developing the WMATA property between the White Flint Metro and Nebel Street. It will be coordinated with the Twinbrook Metro area development, with a focus on creating a research, quantum computing, and Al hub, including a start-up incubator. He has four universities interested in the area. The goal is to foster a critical mass of high-paying science and bio-tech jobs. The timeline is, 1. a joint agreement ready for bid in summer, 2. make a "pitch" to developers in six months, 3. select a master developer. His office is trying to coordinate with Gov. Hogan to have the incentives that the state had promised to Amazon apply to infrastructure and incentives for this project. Turning Rockville Pike into a multi-modal boulevard with bus rapid transit (BRT) is key. BRT will have a dedicated lane and stops every 1/2 mile or so, which augments the Metro station intervals. Whiteflint.org is often a great source for information about the Pike business district.

State Delegate Arianna Kelly is particularly active with health initiatives and has been writing the penultimate *covid-19 information enewsletter*, referred to by every other politician. Access her resources at delegatearianakelly.com/covid-19-information.

Councilmember Andrew Friedson presented a detailed presentation covering topics from covid-19 vaccination and health department updates to the 2022 budget. See his PowerPoint presentation at GreaterFarmland.org/links.

WHERE DO WE LIVE, NORTH BETHESDA OR ROCKVILLE? By Emily Mintz

This is not an either/or question, but depends on context. The simple answer is that you can call it whatever you want, but none of our homes are in the City of Rockville. There are several ways that define location: local governance, planning, postal operations, tax records, and the legal description in property deeds and land records.

- 1. Local governance. Montgomery County is the smallest local governing body for our location. Within Montgomery County, there are several incorporated entities, which include the City of Rockville, Gaithersburg, Somerset, Garret Park Village, Kensington, and a few others. Consider them chocolate chips in a cookie. The county is the cookie, and the incorporated municipalities are dotted within it. Each incorporated town/city/village has its own elections, police & fire departments, along with city taxes. Any place that is not within incorporated boundaries is in Montgomery County proper. The City of Rockville's southern boundary is Montrose Road, and Greater Farmland is outside that boundary. We do not pay Rockville taxes or receive Rockville services.
- 2. Planning districts. Many people think that commonly-recognized areas like Potomac, Bethesda, and Silver Spring are towns, but they are not. They are planning districts within the county and have no distinct governing bodies. The Maryland-National Parks and Planning Commission (MNPPC) was established in 1927 to develop master plans for Montgomery and Prince Georges counties. We live in the North Bethesda/Garrett Park master plan district, which, for nearly seven decades, is defined by the area west of Rock Creek Park, east of I-270, south of Montrose Road, and north of I-495.
- 3. Postal operations. The post office that serves our community, and many others like it, is within the City of Rockville boundaries. When Old Farm and Tilden Woods were built in the early 1960s, the builder advertised them as "Bethesda" homes. The postal service had planned to have mail delivered from a Bethesda post office, but, ultimately, decided to assign the Rockville station on Rollins Avenue. That's how we ended up in 20852 with a Rockville postal address. Nearly 20 years ago, the USPS determined that 20852 is a dual-designation post office. Officially, any of these 3 addresses are acceptable for 20852: Rockville, North Bethesda, or N. Bethesda.
- 4. Tax records, land records, and deeds. Tax records use postal addresses. Since the postal address assigned to our developments at construction was Rockville, it remains so in the tax records. Some properties, when sold, were reassigned as North Bethesda, so that some of our houses show Rockville and some show North Bethesda addresses. Land records and deeds are the official documents defining a property with what's known as a "legal description." Legal descriptions on the east coast use a lot/block/subdivision system. For instance, your property may be noted as Lot 10, Block M, Old Farm. If you look at your deed, it will note your legal description, then say "also known as" and list the postal address for easy reference, since that is how most people describe their properties. This refers back to the semi-arbitrary postal address assigned by USPS.

It's a fallacy that North Bethesda was "invented" by the real estate industry to boost home prices. Names don't alter home values, but the characteristics of the home and community do. North Bethesda has been in existence since MNCPPC created the planning area in our county. In summary, you can use whichever you prefer or feel is more accurate based on your definition of location.

CONTINUING PRESSURE ON WASHINGTON GAS AND WSSC by Ed Rich

Built in the 1960's, our aging water, sewer, and natural gas lines under our streets are concerning. Washington Gas (WGL) has been making spot checks and repairs for years. We are coordinating with WGL regarding on-going work to replace gas lines under our streets and service lines to individual home meters. Gas line work on and around Tildenwood Drive is underway. WGL has promised to have a schedule of upcoming work to share with us shortly. WSSC, our water & sewer service, is addressing water main breaks. GFCA is in constant contact with officials from both WSSC and WGL, as well as with our elected officials. Recently, we have contacted WSSC officials about large increases in water bills for some households. For those of you who provided us with water billing issues, we have passed those along. You should hear directly from WSSC. As a result of widespread digging by both utilities, they have had to resurface some of our streets. Landscaping replacement in the Old Stage Rd/Stonewood Ln traffic circle is paid for by WGL, since repair of the gas leak there. **Please send reports of gas or water main leaks to WGL and WSSC as soon as these are detected. Report gas leaks to WGL at 703-750-1000 and broken water main or sewage emergencies to WSSC at 301-206-4002 or emergencycallcenter@wsscwater.com. GFCA maintains a master list of natural gas leak locations to address with WGL en masse, so, please, also report gas leaks to info@greaterfarmland.org.**
