IS YOUR TAX ASSESSMENT BELOW \$650,000? BEEN IN YOUR HOUSE OVER 40 YEARS?

There is a new 20% Montgomery County property tax break available, but you must apply for it by April 1 for next July's property tax bill. The requirements are:

- 1. You must have lived in your current house for 40+ consecutive years, and
- 2. Your property tax assessment can't exceed \$650,000

Many homes in Tilden Woods can meet the assessment criterion, and some in Old Farm or Walnut Woods might. You can check your tax assessment at https://sdat.dat.maryland.gov/RealProperty/Pages/default.aspx.

NEW PARK AT SHRIVER AQUATIC CENTER

The White Flint Sector Plan calls for a new park where the Shriver Aquatic Center parking lot is currently located. The plan calls for building a parking garage between the Aquatic Center and the Gables apartment project, which will be just to the north of the Center once Executive Boulevard has been straightened. GFCA, as a voting member of the White Flint Sector Implementation Committee, pressed the County to appropriate funds so that parking for the apartments and the public aquatic center would be built at the same time. We are pleased to announce that the County has finally agreed to appropriate the needed funds. In the near future, there will be a large, grassy area replacing the surface parking lot and a new covered entrance for the Aquatics Center. This is the first step in the plan to build a regional service/recreation center next to the Aquatic Center. We remain the only part of the County that does not have a service/recreation center. Your civic association will continue to push for this new resource for our neighborhood.
